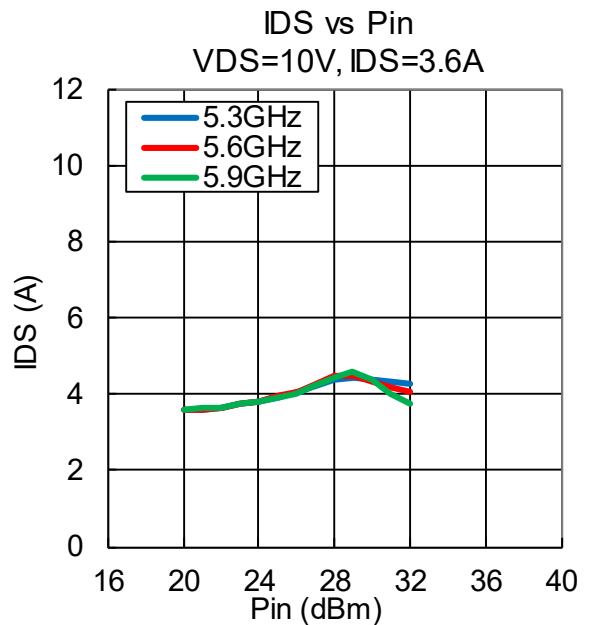
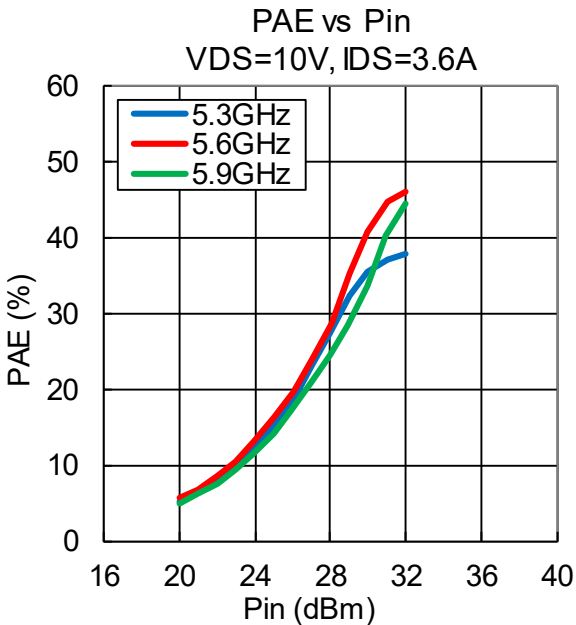
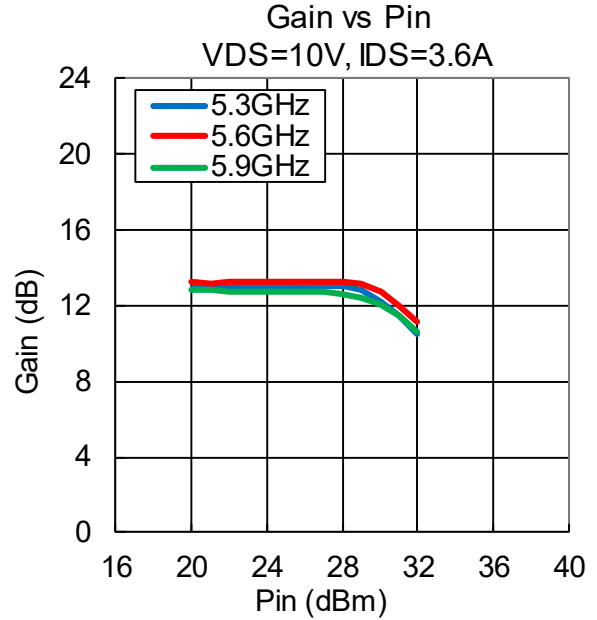
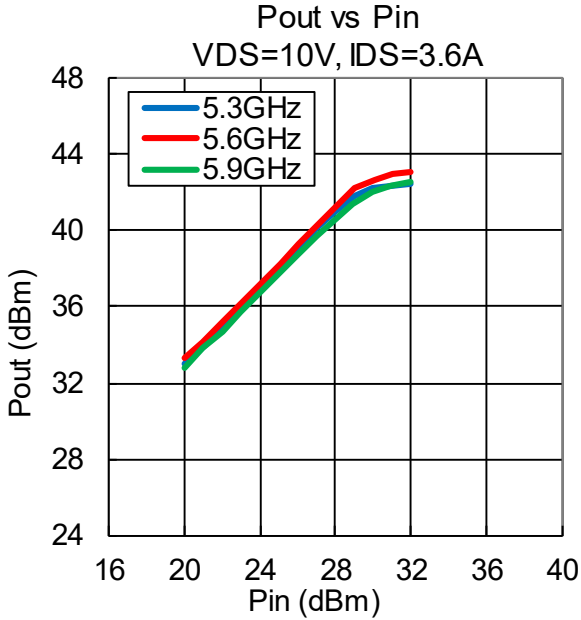
HANDLING PRECAUTIONS FOR PACKAGE MODEL

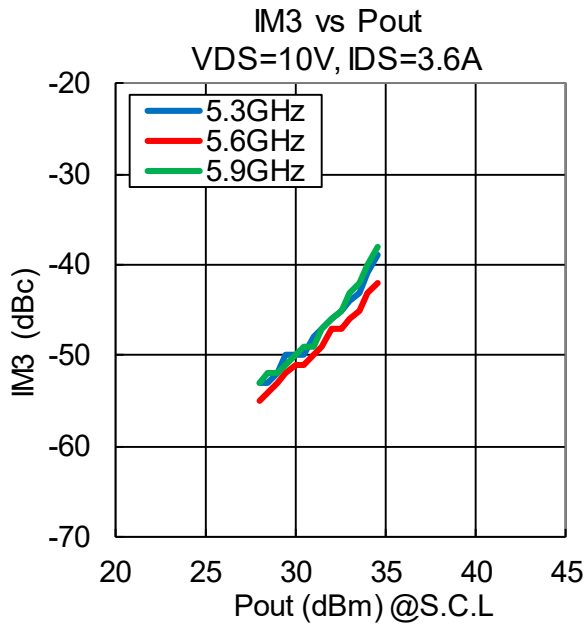

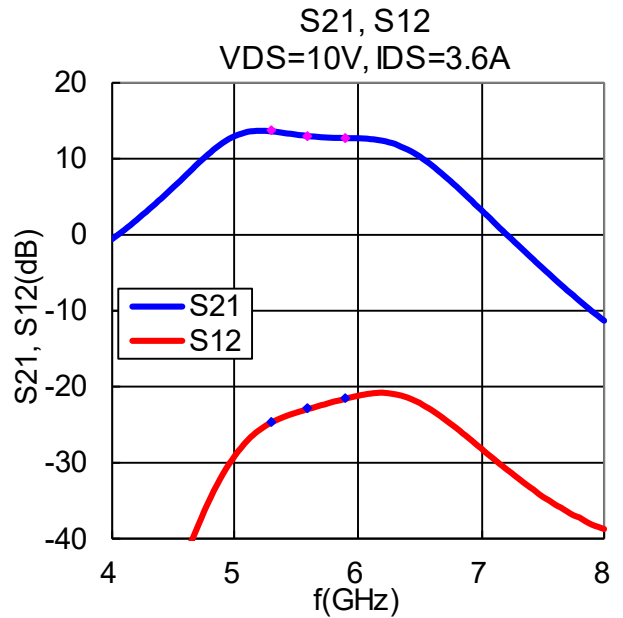
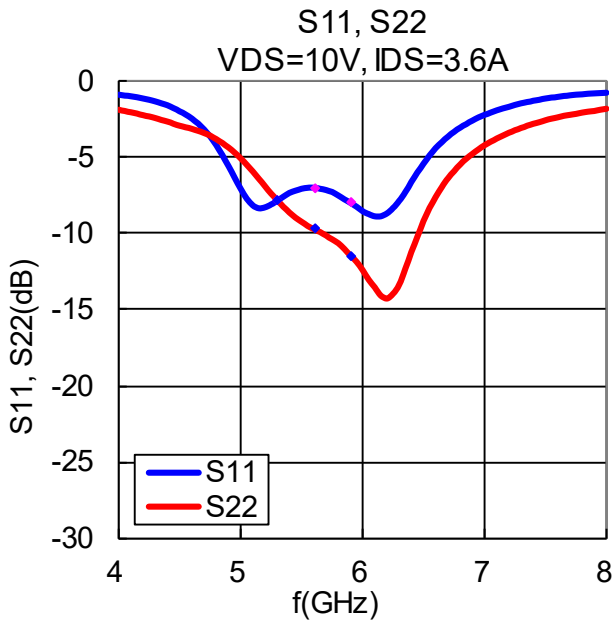
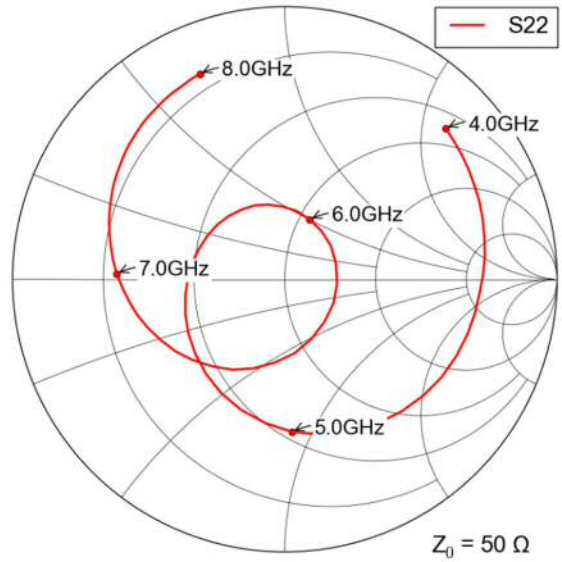
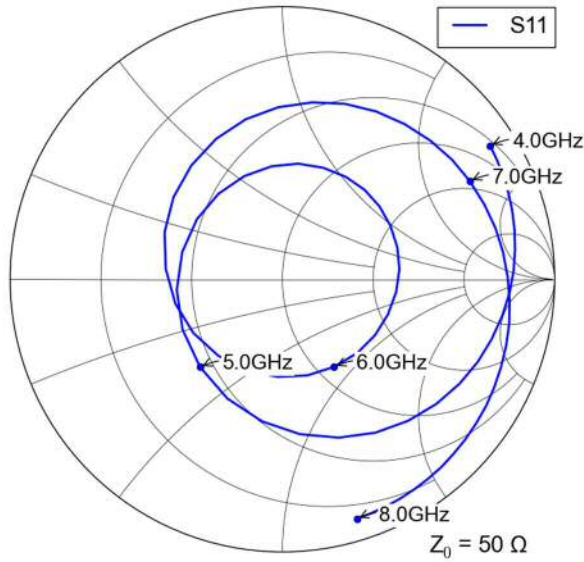
IM3 vs. Pout
