Notice Regarding Establishment of the Governance Enhancement Committee

As described in "Notice Regarding Company's Response to the Investigation Report" dated June 13, 2021, in response to the indication in the investigation report (the "Investigation Report") from the Persons Who Will be Charged to Investigate the Status of the Operations and Property of the Stock Company pursuant to Article 316, Paragraph 2 of the Companies Act (the "Investigators") that the 181st Annual General Meeting of Shareholders held on July 31, 2020 was not conducted fairly as required by the Corporate Governance Code, Toshiba Corporation (the "Company") announced that "we will take action to identify the root cause without delay, in an objective and transparent manner, including the participation of third parties," and "we will clarify responsibilities, take proper measures to prevent reoccurrence." Accordingly, the Company came to a decision to establish the Governance Enhancement Committee (the "Committee") as follows and to assign to it the missions stated in 1 below:

1. Missions assigned to the Committee

With regard to the following issues indicated as a part of "Pressure Issues" in the Investigation Report:

- 1) Analyzing the root cause;
- 2) Clarifying responsibilities; and
- 3) Making suggestions for developing measures to prevent reoccurrence.

Please note that it is not intended to reinvestigate the facts found by the Investigators while additional investigation including interviewing related persons will be undertaken for root cause analysis and clarifying responsibilities.

In terms of governance issues, including shareholder relations, and future directions of governance to aim for, etc., the Committee will seek feedback from academic and other experts, along with conducting discussions among the Committee members, to prepare the final report.

3. Schedule

The final report is expected to be submitted by the Committee in October 2021.

4. Treatment of compensation for former officers

Under the Allotment Agreement for Shares of Restricted Stock with former directors and executive officers who resigned in April and June this year, if it is found that certain events such as the allottees violating the law have occurred, where the Company deems it appropriate, the allottees should immediately return such stocks to the Company without compensation. Taking into consideration the findings of the Committee concerning clarifying responsibilities, the Company intends to require the former officers to return the stocks without compensation, if necessary.

In addition, as mentioned in the Securities Report for the 182nd fiscal period, the Company intended to suspend the payment of FY2020 performance-linked compensation for such former executive officers until the completion of the investigation of the root cause. However, the Company will make such payment in accordance with the provisions of the relevant internal rules and the contractual obligations arising therefrom, subject to the maximum reduction based on each former executive officer's individual evaluation to the extent allowed by such internal rules. With taking into consideration the findings of the Committee concerning clarifying responsibilities, the Compensation Committee will further discuss and decide the final amount of the reduction.
